BOURBON COUNTY SPEEDING DIVERSION GUIDELINES AND DIVERSION PROGRAM, EFFECTIVE JULY 2020

The County Attorney for Bourbon County, State of Kansas has established the following guidelines for a diversion program for excess speed offenders.

The Bourbon County Attorney and Assistant Bourbon County Attorneys make all the decisions regarding the diversion policy and determining eligibility, including conditions for diversion contracts.

The Bourbon County Attorney's office will offer a diversion for persons charged with speeding. If the defendant successfully completes the diversion program, the defendant's speeding charge will not be referred to the State.

DIVERSION CRITERIA

- 1. If you have been convicted of speeding in the last twelve (12) months, you are not eligible for a diversion.
- 2. If you have a commercial drivers' license (CDL), you are not eligible for a diversion.
- 3. If you were cited for more than 20 miles over the speed limit, you are not diversion eligible.

DIVERSION POLICY

The defendant must submit an application for diversion and pay the non-refundable application fee of \$50.00 to be considered for a diversion.

The defendant will be required to pay the Court Costs as set by the Court Clerk according to law; the defendant will be required to pay the Fine as set by Statute; the defendant will be required to pay a Diversion Fee as set by the County Attorney according to law. The defendant will pay all sums in advance to the Bourbon County Attorney's Office.

ALL COURT COSTS, FINES AND FEES MUST BE PAID AT THE TIME THE DIVERSION AGREEMENT IS SIGNED.
